

THIRD PARTY DATA PROVIDER TERMS AND CONDITIONS

In addition to the terms and conditions of any agreement you may have to access information or services from the MarketAxess group of companies (“**MarketAxess**”), certain third-party data providers also impose additional terms and conditions in connection with the use of, and access to, their data (“**Third Party Data**”). The additional terms and conditions below apply to you to the extent you access Third Party Data from each relevant third-party data provider through MarketAxess.

Reference to a ‘Customer’ herein refers to a Participant accessing the Trading System operated by MarketAxess and where such Third Party Data is displayed or a Customer of the MarketAxess data products.

1. CUSIP Global Services

Any use by Customer outside of the clearing and settlement of transactions requires a license from CGS along with an associated fee based on usage. To the extent applicable, CGS data may only be downloaded by a desktop user to a desktop/computing device used solely for such desktop user’s individual use and not for any centralized, interdepartmental or shared use. Once downloaded to a desktop user’s desktop/computing device, the CGS data must remain on such desktop user’s desktop/computing device and may not be uploaded, copied, transferred to, stored or managed in any other desktop/computing device, including that of another desktop user, or any device, directory, database or other repository that is shared or can be accessed by others (e.g., the download functionality may not be used to populate master security databases). - 5.9. The Customer shall comply with any investigation undertaken by the UK Financial Conduct Authority or any other regulator in relation to the ETS data or the consolidated tape for bonds.
- 5.10. The Customer acknowledges that the ETS data is comprised of data provided to ETS by third parties and that neither MA nor ETS shall have any liability to the Customer or any other person for any such third-party data (including where such data has been incorporated into the ETS data).
- 5.11. TO THE FULLEST EXTENT PERMITTED BY LAW, THE ETS DATA IS PROVIDED "AS IS" AND ON AN "AS AVAILABLE" BASIS. NEITHER MA NOR ETS GIVES ANY WARRANTY OF ANY KIND, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, GOOD TITLE, SATISFACTORY QUALITY AND NON-INFRINGEMENT.
- 5.12. The Customer acknowledges that ETS holds and maintains records of how its data is distributed and used (including records of the persons that have access to the data and the persons to whom fees are paid for such access). ETS may provide information from those records to regulatory bodies and to its redistributors. In the event of any dispute, disagreement or uncertainty regarding the same, ETS's records shall be treated as authoritative.

- 5.13. Notwithstanding clause 16.3 of the Master Agreement for Supply of Data (or any equivalent audit provision in the Customer's agreement with MA), the Customer's obligation to maintain records relating to the ETS data and to permit audits in respect of such data shall continue for a period of two (2) years following termination or expiry of the Customer's right to access the ETS data.
- 5.14. The Customer's right to access and use Third-Party Provider data shall automatically terminate upon the earlier of: (a) termination of the relevant SOF; (b) termination or expiry of MA's agreement with the relevant Third-Party Provider; or (c) a direction from the relevant Third-Party Provider requiring MA to terminate the Customer's access.
- 5.15. Upon termination of access to any Third-Party Provider data, the Customer shall, within thirty (30) days: (a) cease all use of such data; (b) delete or destroy all copies of such data in its possession or control (including in any databases, archives and backup systems); and (c) upon MA's written request, certify in writing that it has complied with the foregoing. The obligation to delete or destroy shall not apply to the extent retention is required by applicable law or regulation, provided that any retained data shall remain subject to applicable confidentiality and use restrictions.
- 5.16. For the avoidance of doubt, references to the ETS data in the Customer's post-termination obligations (including the obligation to cease use of, and to delete or destroy, the ETS data) shall be deemed to include any data derived from the ETS data that is capable of being reverse-engineered to create or reveal any element of the ETS data.
- 5.17. Where necessary, Customer shall clearly attribute ETS as the source of the bond trade data, including by way of any attribution wording notified to the Customer by MA from time to time.
